

AnonymouslyUrs.net Terms of Use

Welcome to AnonymouslyUrs.net. These Terms of Use ("Terms") govern your access to and use of the AnonymouslyUrs.net website, web application, SMS messaging program, and related services (collectively, the "Services").

By accessing or using the Services, you agree to be bound by these Terms and our Privacy Policy. If you do not agree to these Terms, you may not use the Services.

1. Acceptance of Terms

By creating an account, using any feature of the Services, or receiving SMS notifications from us, you acknowledge that you have read, understood, and agree to be bound by these Terms, our Privacy Policy, and our SMS Messaging Policy.

We reserve the right to modify these Terms at any time. If we make material changes, we will notify you by email, through the Services, or by other reasonable means. Your continued use of the Services after any changes constitutes acceptance of the revised Terms.

2. Description of Services

AnonymouslyUrs.net provides a faith-based encouragement and prayer platform that allows users to:

1. Create and share anonymous encouragement messages and prayers.
2. Use AI-powered tools to help generate prayers, reflections, and supportive messages.
3. Send SMS notifications to recipients with a secure web link to view encouragement messages.
4. Access additional faith-based tools such as Bible study assistance and life coaching features.

The Services may include both free and paid subscription tiers, with access to features determined by your subscription level.

3. Eligibility

You must be at least 13 years of age to use the Services. If you are between 13 and 18 years of age (or the age of legal majority in your jurisdiction), you may only use the Services under the supervision of a parent or legal guardian who agrees to be bound by these Terms.

By using the Services, you represent and warrant that you meet these eligibility requirements.

4. Account Registration and Security

4.1 Account Creation

To access certain features, you may need to create an account by providing a valid email address, display name, and password. You agree to provide accurate and current information during registration.

4.2 Account Security

You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. You agree to:

1. Choose a strong, unique password.
2. Not share your account credentials with others.
3. Notify us immediately if you suspect unauthorized access to your account.

We are not liable for any loss or damage arising from your failure to protect your account credentials.

5. Acceptable Use and Prohibited Conduct

You agree to use the Services only for lawful purposes and in accordance with these Terms.

You agree NOT to:

5.1 Prohibited Content

1. Post, transmit, or share content that is harassing, threatening, defamatory, hateful, or that promotes violence or discrimination.

Share content that promotes, glorifies, or provides instructions for self-harm, suicide, or violence against others. *(Note: We recognize that users may share personal struggles, including mental health challenges, in prayer requests. Such honest sharing is permitted when seeking support, but content that instructs or encourages harmful behavior is strictly prohibited.)*
4. Post content that is fraudulent, deceptive, or misleading, or that promotes illegal activity.
5. Use the Services for spam, unsolicited commercial messages, or mass messaging campaigns.

5.2 Prohibited Behavior

1. Attempt to identify, expose, "dox," or harass recipients or senders of anonymous messages.
2. Impersonate any person or entity, or falsely state or misrepresent your affiliation with any person or entity.
3. Interfere with or disrupt the Services, servers, or networks connected to the Services.
4. Attempt to gain unauthorized access to any portion of the Services, other user accounts, or systems.
5. Use any automated means (bots, scrapers, scripts) to access the Services without our express written permission.
6. Use the Services to violate any applicable local, state, national, or international law.

5.3 Consequences of Violation

We reserve the right to investigate, suspend, or terminate your account, and to remove or restrict access to any content, at our sole discretion, if we believe you have violated these Terms or engaged in conduct that we determine is harmful to other users, to us, or to third parties.

6. AI-Generated Content and Disclaimers

6.1 Use of AI

The Services use artificial intelligence (including OpenAI's GPT models) to help generate prayers, reflections, and supportive messages based on user input. AI-generated content is created by automated systems and is intended to provide general encouragement and spiritual support.

6.2 No Professional Advice

AI-generated content is NOT professional advice. The Services, including AI-generated outputs, do not constitute:

1. Medical advice, diagnosis, or treatment.
2. Mental health counseling, therapy, or crisis intervention.
3. Legal, financial, or professional advice of any kind.

AI outputs may contain inaccuracies, errors, or content that is not suitable for your specific situation. You should not rely solely on AI-generated content for important personal, medical, or legal decisions.

6.3 Not a Substitute for Professional Help

If you are experiencing a medical emergency, mental health crisis, or suicidal thoughts, **do not use the Services as a substitute for professional help.** Please contact emergency services (911 in the U.S.), a crisis hotline (such as the National Suicide Prevention Lifeline at 988), or a licensed healthcare provider immediately.

6.4 General Encouragement Only

The Services are designed to provide faith-based encouragement, prayer support, and general spiritual guidance. While we may offer "coaching" or "guidance" features, these are not substitutes for professional counseling, therapy, or medical treatment. You use the Services and any AI-generated content at your own risk.

7. User Content and Intellectual Property

7.1 Your Content

You retain ownership of any prayers, messages, reflections, or other content you create or submit through the Services ("User Content"). By submitting User Content, you grant us a limited, non-exclusive, royalty-free, worldwide license to:

1. Store, process, display, and transmit your User Content as necessary to provide and operate the Services.
2. Use your User Content to improve the functionality, performance, and user experience of the Services (but not for AI training or creating derivative works without your consent, unless you explicitly opt in to such uses in the future).

This license terminates when you delete your User Content or your account, except where retention is required for legal, security, or compliance reasons as described in our Privacy Policy.

7.2 Our Intellectual Property

The Services, including all software, design, text, graphics, logos, trademarks, and other materials, are owned by AnonymouslyUrs or our licensors and are protected by copyright, trademark, and other intellectual property laws.

You are granted a limited, non-exclusive, non-transferable, revocable license to access and use the Services for personal, non-commercial purposes in accordance with these Terms. You may not:

1. Copy, modify, distribute, sell, or lease any part of the Services.

8. Subscriptions, Billing, and Payments

8.1 Subscription Plans

AnonymouslyUrs.net offers both free and paid subscription plans. Paid plans may be billed on a monthly or annual basis, and grant access to premium features, additional AI credits, and other benefits.

8.2 Payment Processing

All payments are processed securely through Stripe, a third-party payment processor. By subscribing to a paid plan, you agree to provide accurate billing information and authorize us (via Stripe) to charge your payment method for the applicable subscription fees.

We do not store your full credit card number or CVV; Stripe handles all sensitive payment information.

8.3 Billing and Renewals

1. **Monthly subscriptions** automatically renew each month on your billing date until you cancel.
2. **Annual subscriptions** automatically renew each year on your billing date until you cancel.

You will be charged on each renewal date unless you cancel your subscription before the renewal date.

8.4 Cancellation and Refunds

1. **Monthly subscriptions:** You may cancel your subscription at any time through your account settings or by contacting support. Cancellation will take effect at the end of your current billing period. **No refunds or credits will be provided for partial months.**
2. **Annual subscriptions:** You may cancel your annual subscription at any time; however, **no refunds will be provided for the unused portion of the annual subscription, except as required by law.**
3. We reserve the right to issue refunds or credits on a case-by-case basis at our sole discretion (for example, in cases of billing errors or technical issues).

By providing a mobile phone number to send encouragement messages, you acknowledge that the recipient may receive SMS notifications from AnonymouslyUrs.net containing a secure web link to view the message.

Our SMS program operates in accordance with our SMS Messaging Policy, which includes:

1. One notification SMS per recipient unless they opt in by replying YES.
2. Recipients may opt out at any time by replying STOP.
3. SMS messages do not contain full message content; all content is viewed via a secure web link.

9.2 Email Communications

We may send you service-related emails (such as account notifications, billing receipts, and security alerts). You may also receive optional encouragement-related emails if you opt in. You can manage your email preferences in your account settings or by using the unsubscribe links in our emails.

The Services, including SMS and email, are not intended for emergency communication or crisis intervention. If you are experiencing a medical or mental health emergency, contact emergency services immediately (dial 911 in the U.S. or your local emergency number).

10. Content Moderation and Removal

We reserve the right, but not the obligation, to monitor, review, and moderate User Content and activity on the Services. We may, in our sole discretion:
